WARRANT ROUND UP NOTIFICATION

If you have not made arrangements with the Castroville Municipal Court to take care of any tickets or warrants that you received in the City of Castroville, now is the time. On Saturday, April 16, 2016, members of the Castroville Police Department will be going to the homes and places of employment for those who have outstanding tickets with the City.

If you cannot pay your fine when caught, you could be taken to the Medina County Jail. **Please contact the Castroville Municipal Court at 830 931-4070, to make arrangements,** otherwise, expect to see Officers at your door.

BRUSH PICKUP

The City of Castroville brush pickup is the second week of the month. Please place the brush on the curb on Monday and it will be picked up by the end of the week.

Please put the brush in a clear area in front of your residence. Avoid discarding brush under power lines or trees as our equipment cannot pick up under these areas. Please do not place brush on curb more than a week before pickup.

No more than 8 cubic yards, as seen below, will be picked up.
