On January 27, 2021, the Castroville Police Department received its certification for safe policing for communities. The certificate is through the Texas Police Chiefs Association Foundation and the Texas Law Enforcement Best Practices Recognition Program. It is pursuant to section 2 of the President's Executive Order No. 13929 for Safe Policing in Communities. The certification allows police departments to file for federal grants.

The Police Department received a coffee donation of over \$2,000.00 in product for first responders from the Black Rifle Coffee Co. The Black Rifle Coffee Co. is operated and owned by veterans located in Boerne, TX.

A message from the City Secretary/Election Coordinator on the 2021 General Election

The last day for submitting applications for District 1, District 2, and Mayor was February 12th by 5 pm. The last day for a candidate to have withdrawn was February 19th by 5 pm. The drawing for placement on the ballot will be held on February 25th for District 1 and the mayor's positions.

Early voting will begin on April 20th and end on April 28th. May 1st is Election Day.

The Polling place for the upcoming joint General and School Elections will be at the Medina County Annex Building, Precinct 2, located at 8366 FM 471 South, Castroville, Texas. Please continue to watch for any new information in the monthly newsletters and on the city website.

Stage 1 of the EAA drought plan requires Edwards groundwater permit holders in Atascosa, Bexar, Caldwell, Comal, Guadalupe, Hays, and Medina counties to reduce their annual authorized pumping amount by 20 percent. The purpose of mandatory pumping reductions is to stabilize water levels and spring flow until rainfall replenishes the aquifer.
