UPDATED BILLING PERIOD

BULK AND BRUSH COLLECTION SCHEDULE

Effective October 1, 2023, residents may place a total of 6 cubic yards at the curb once a month of either bulk or brush items.

Bulk and brush items must be in separate piles, one pile for bulk and one pile for brush.

Collection period occurs during 2nd full week of each month.

Bulk and brush items must be placed curbside for collection no later than 7:00 a.m. on the Monday of the collection period.

Collection services will not take place on Thanksgiving, Christmas Day, and New Years Day
