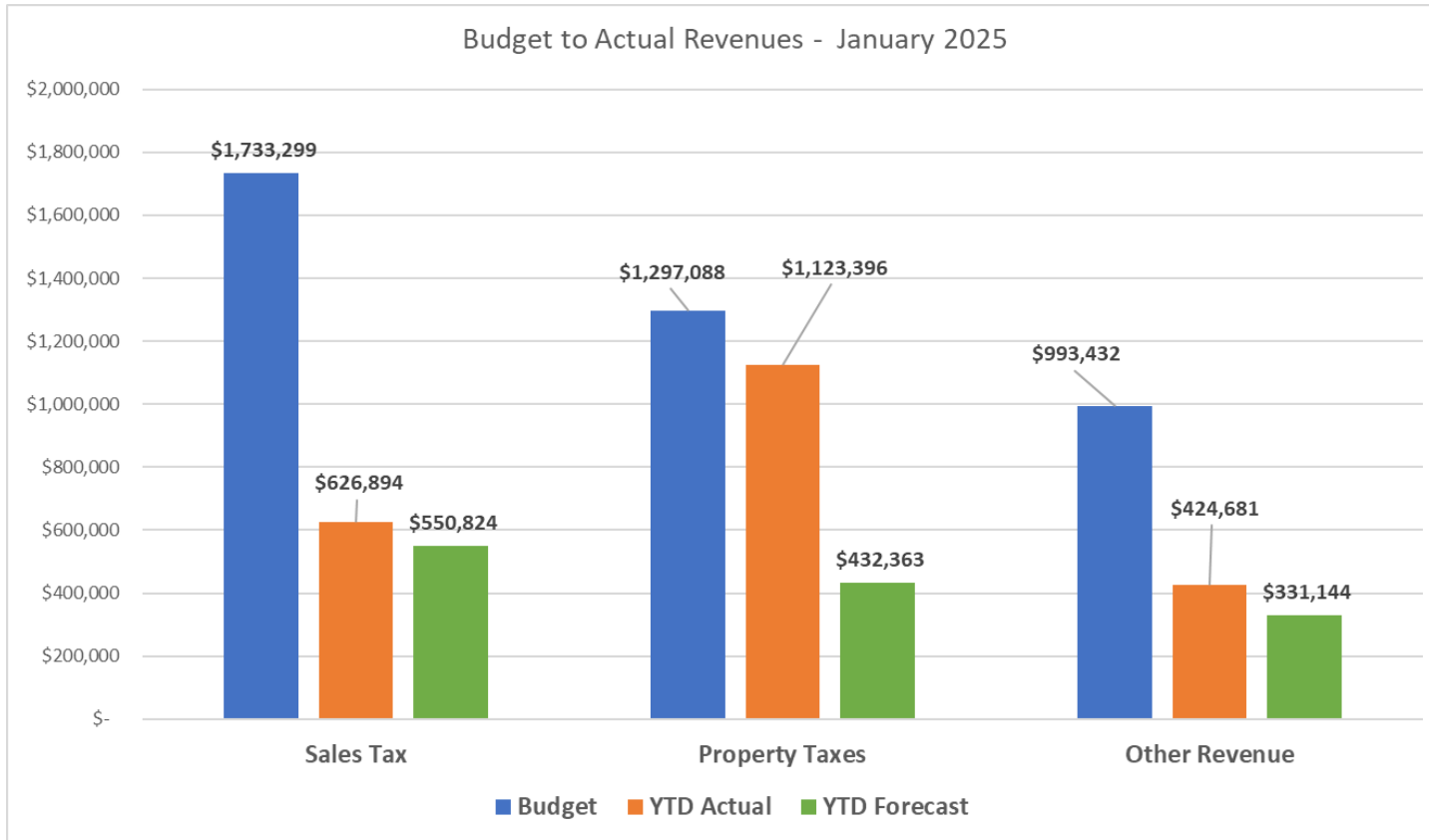

# GENERAL FUND YTD COMPARISON

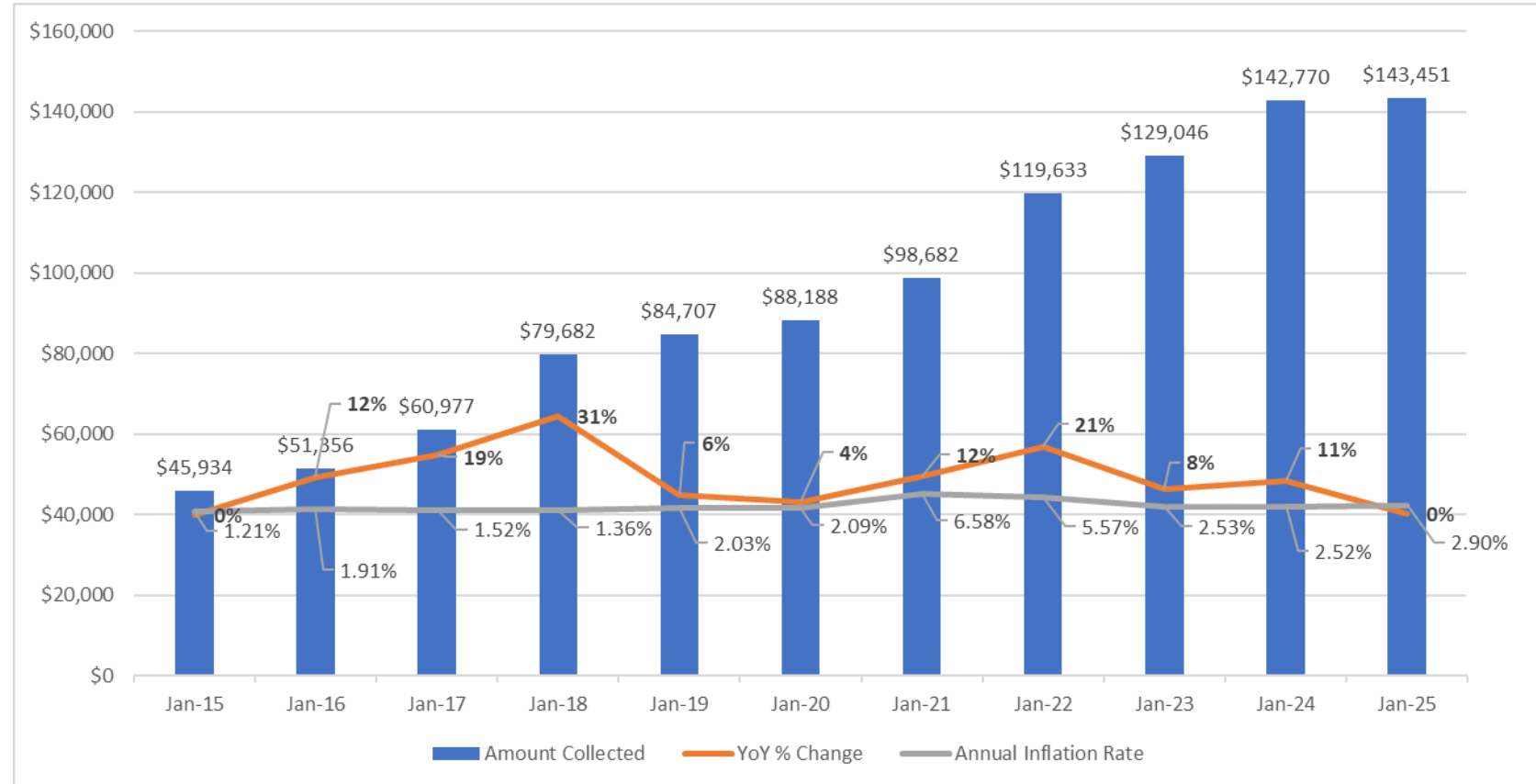


- **Blue** = Total amount budgeted for the year

- Sales tax collections for the month of January totaled \$150,697 (includes sales and liquor tax) compared to last year, total collected for the month of January 2024 was \$147,592
- Property tax collections for the month of January totaled \$419,597 compared to last January 2024, total collected was \$641,298
- Other Revenue includes municipal court, parks and recreation and other misc. revenue.

## Comparison of Annual Collections for the month of January.

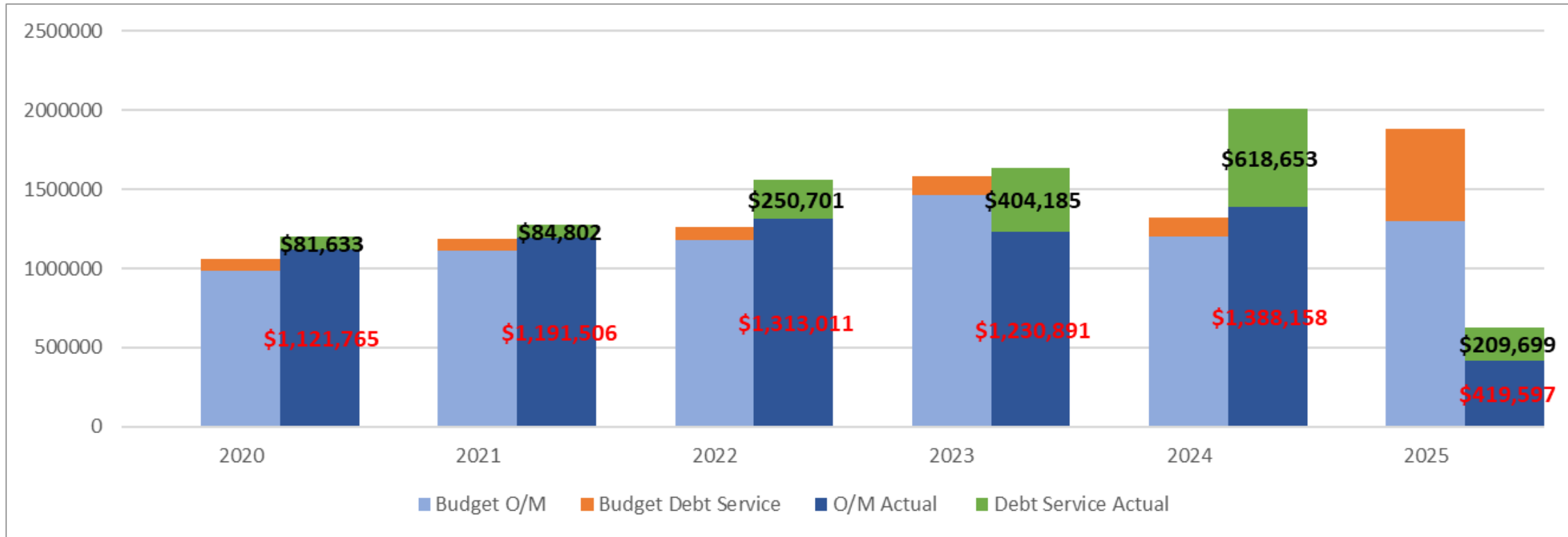
# Sales taxes flat in January.

- Sales tax collections for the month of January totaled \$143,450.53. This amount is true sales tax (does not include liquor tax). This represents an increase of 0.48%, or \$681 compared to last year.
- Through January, sales tax collections are up \$34,856, or 6.14%, from the prior year.
- Collections for this month represent sales that took place in November.



# Property Tax Collections

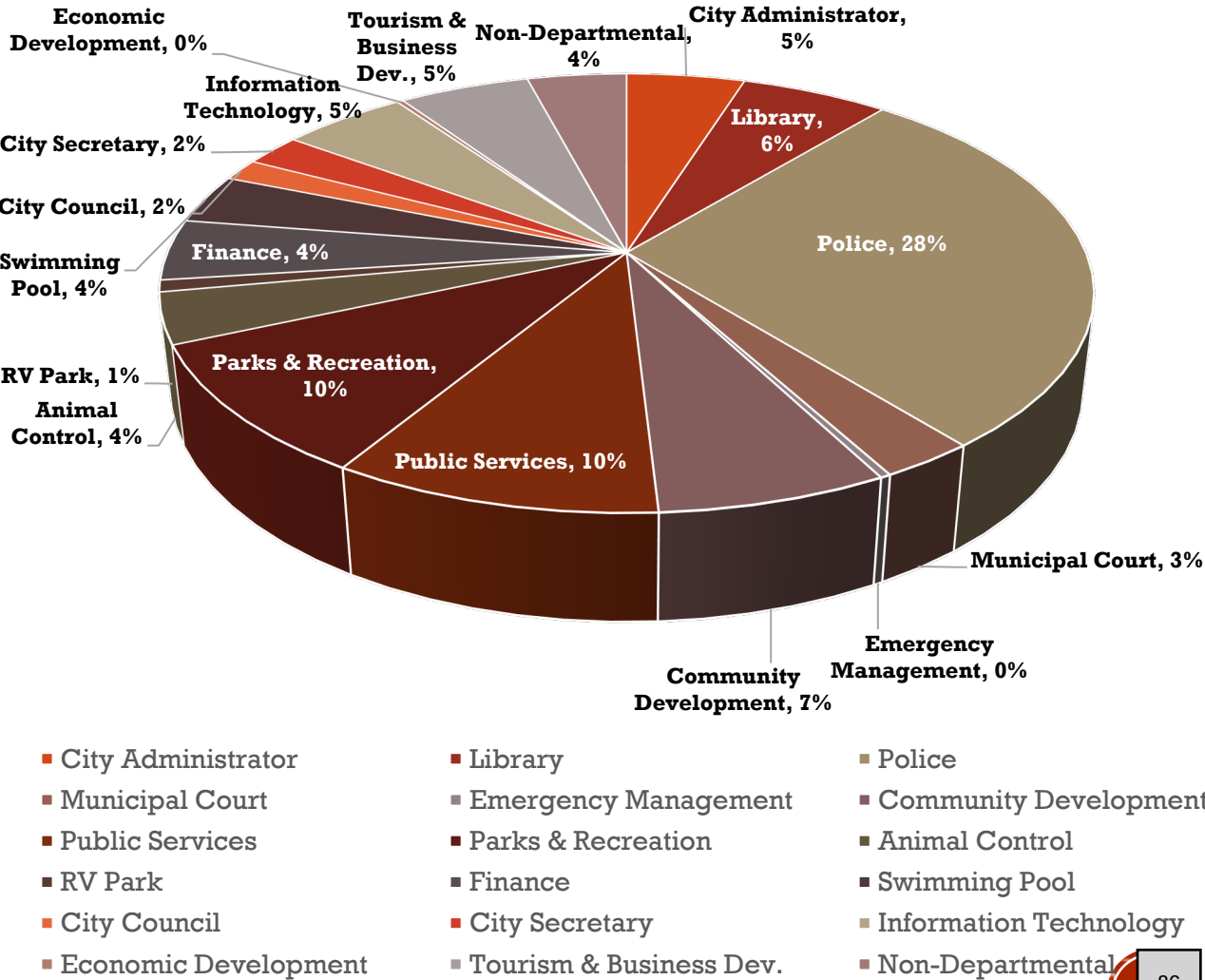
- Current property tax collections are 86.61% of the original budget at this point of the fiscal year. This includes ad valorem, delinquent and penalties and interest. We have collected 84.04% of the total tax levy. Taxes become delinquent on February 1<sup>st</sup>. January is the last month to pay without penalties.
- Delinquent property taxes represent collections on prior year levies. Penalty and interest are being collected on prior year taxes.
- Total property tax collections year to date including prior year collections, as well as penalties and interest for January are \$1,123,396.

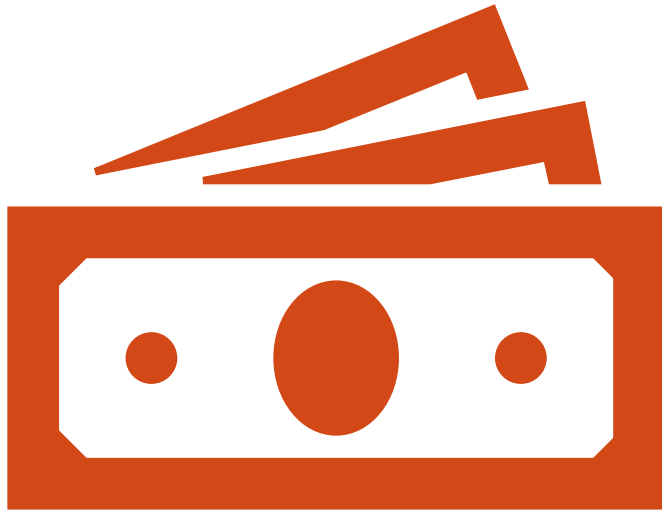

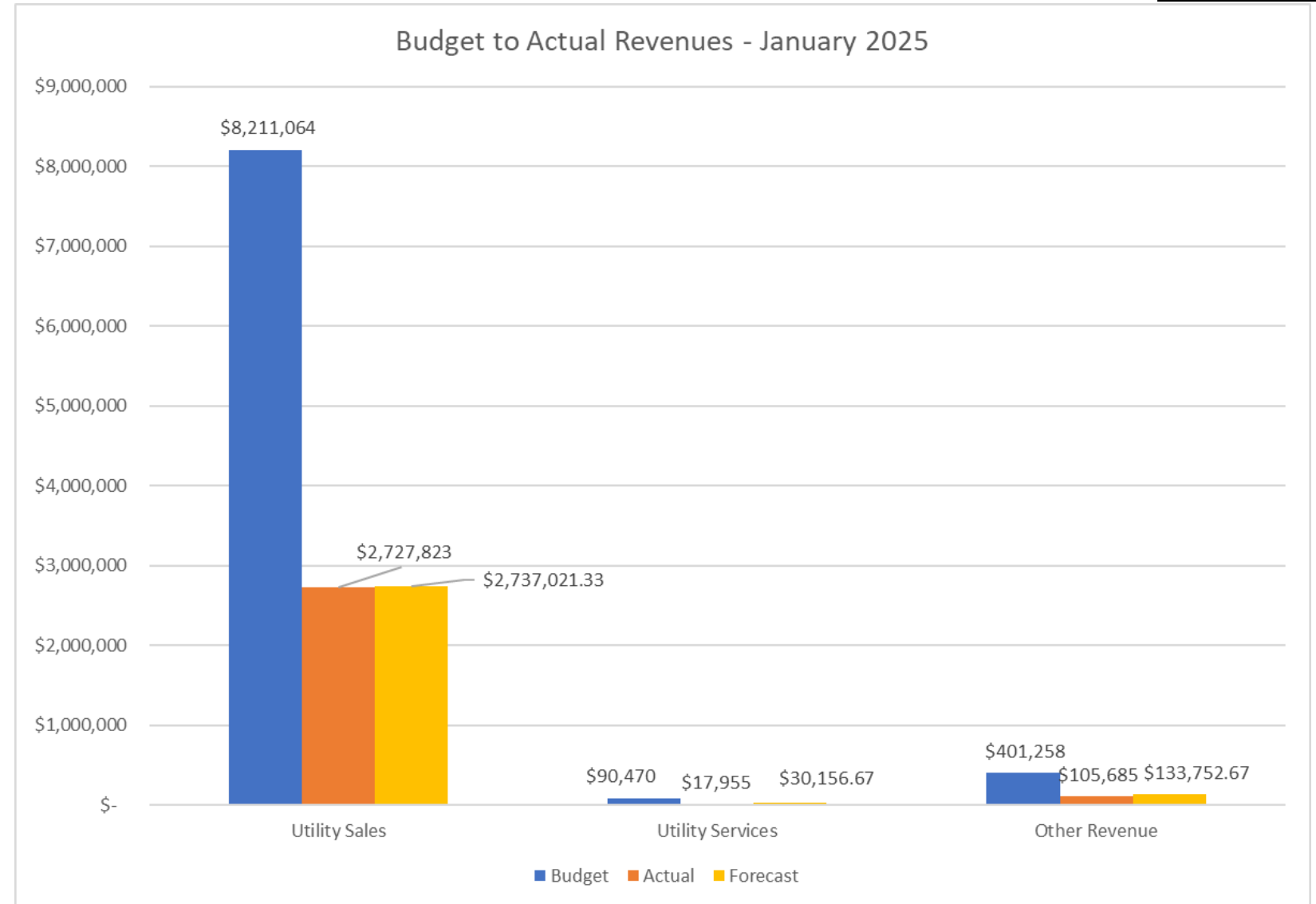

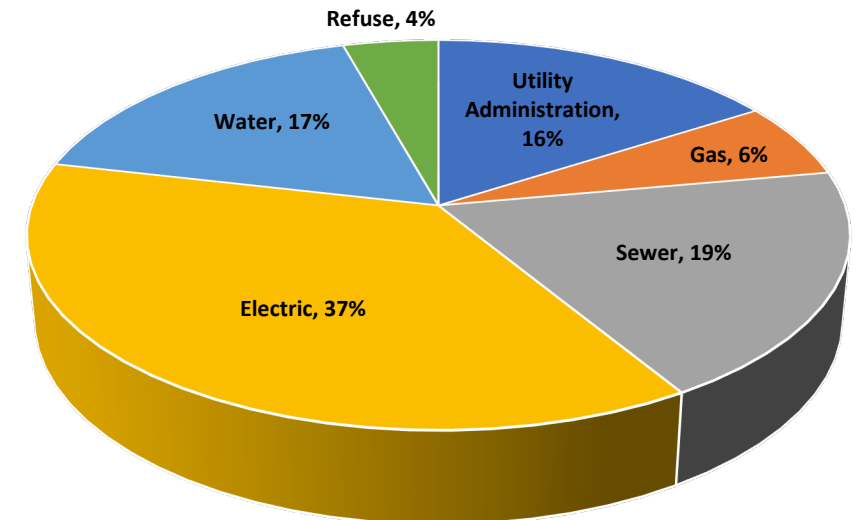
## Utility Fund Revenues (January 2025)

- Last year (2024) total collections during the month of January was \$917,850. This is a 9.9% decrease compared to last year.



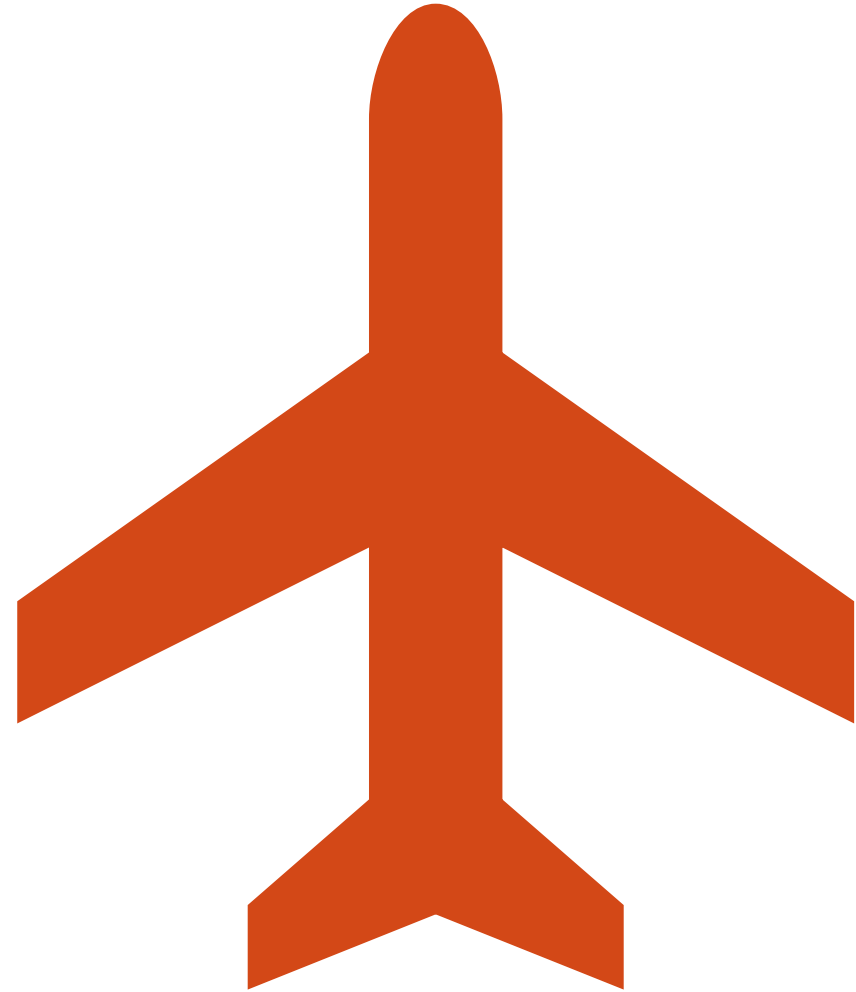

- The above graph represents YTD actual expenditures by department.
- The largest portion of the budget is allocated to Electric (37%), followed by Sewer (19.1%), Water, Utility Administration and Gas
- The percentage of actual YTD spending compared to the adopted budget is about 26.80% overall
- Most departments still have over 60% of their budget unspent.
- Electric and Sewer have spent the lowest percentage of their budget so far while Water and Gas have a relatively high percentage of their budget spent.

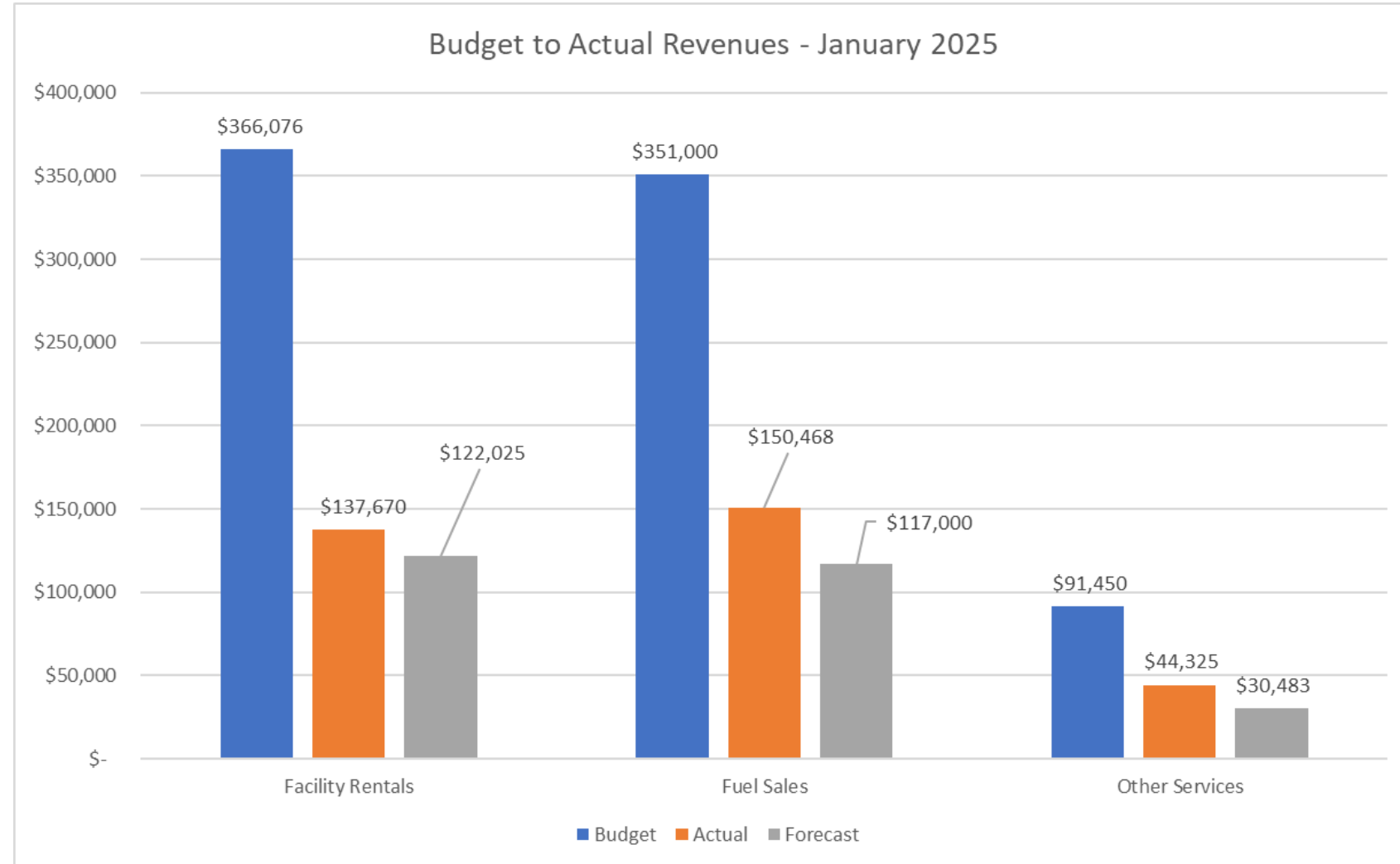
# AIRPORT FUND





## Airport Fund YTD Comparison

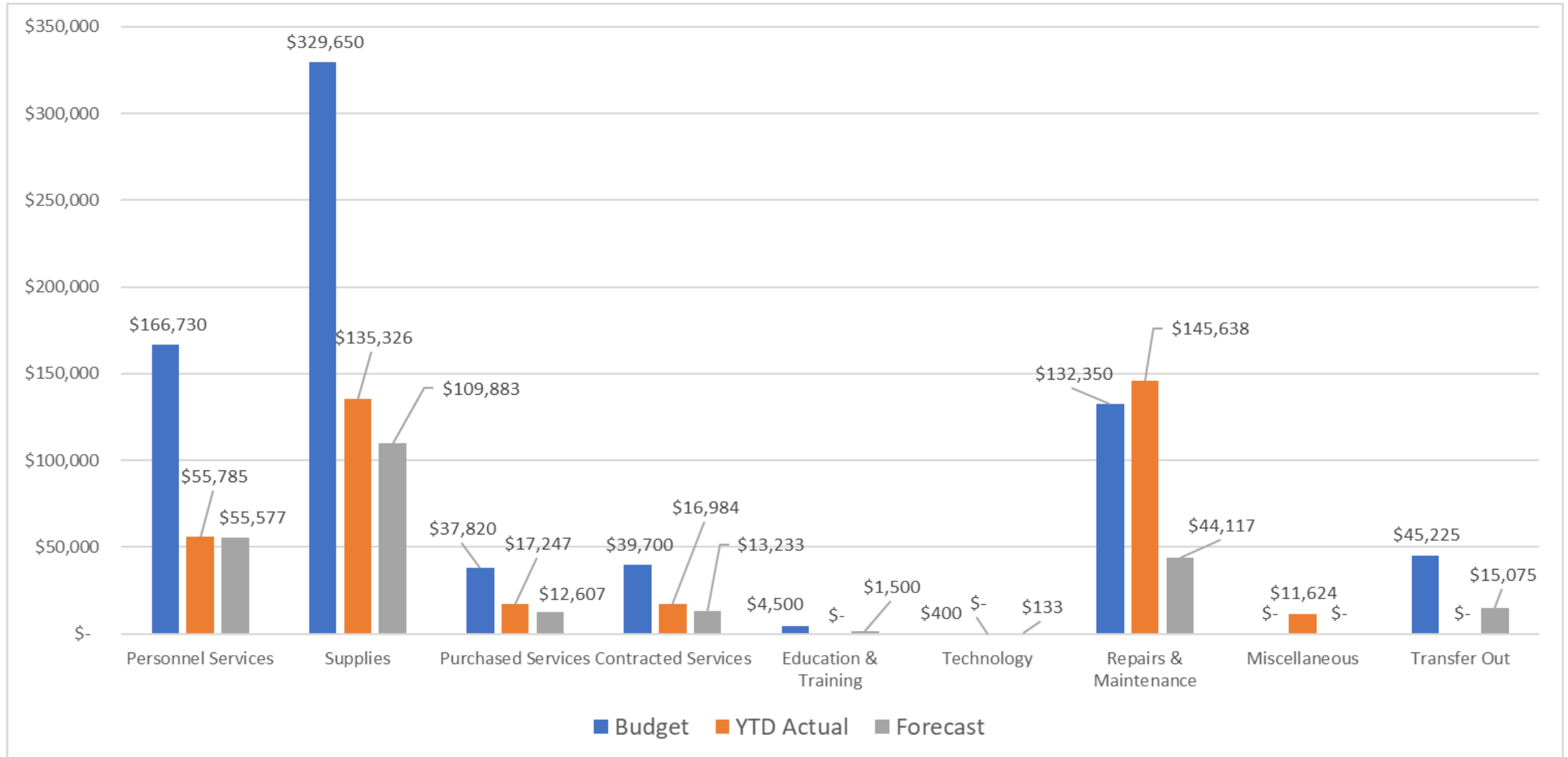
- Currently collected \$56,131 in airport revenues for the month of January 2025.
- Total YTD Collections are \$332,464. This includes facility rentals, fuel sales and other misc. revenue.
- Last year (2024) total collections during the month of January was \$260,170. This is a 27.79% increase compared to last year.

### January 2025



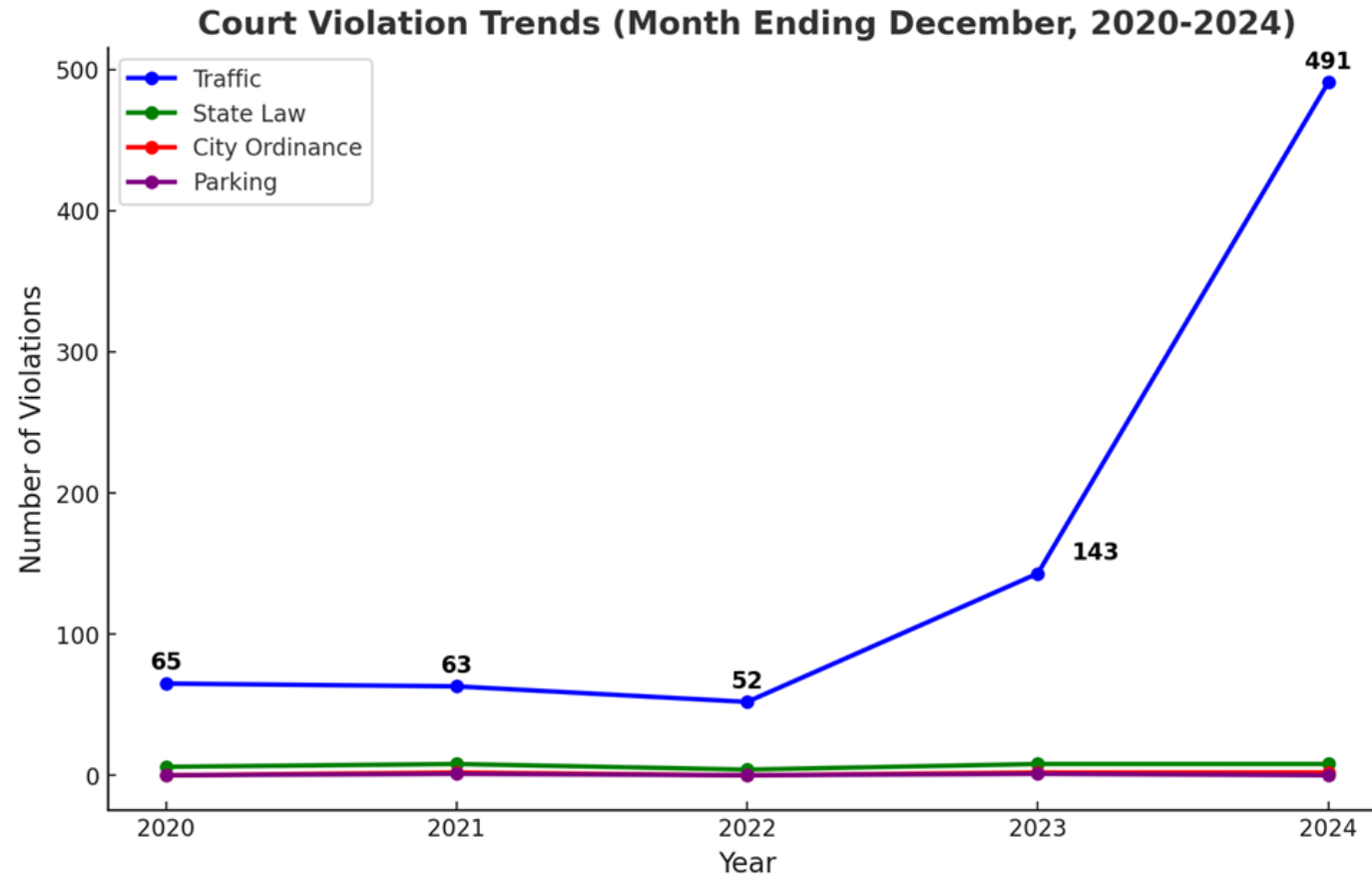
# MUNICIPAL COURT REPORT

---

Report Ending December 2024

(This court report will always be 2 months behind when reporting)





- The above data represent the number of ticket violations for the month of December for 2020 – 2024.
- The number of traffic cases surged dramatically in 2024 (491 cases) compared to previous years, showing a notable shift in enforcement or violations.
- State law cases have remained relatively consistent over the years, suggesting no significant changes in legal trends or enforcement.
- Minimal City Ordinances are sporadic and have remained low, indicating limited violations.
- Only one parking case was recorded in 2023 and 2021, reinforcing a low level of parking-related enforcement or compliance with regulations.
